### **GENERAL INSTRUCTIONS**

- 1) No provision for reservation exists for the posts to be filled up on deputation basis.
- 2) The deputation is against the vacancy arised due to the relieving of Executive Engineer (Civil) on deputation to Government of Kerala. The period of deputation shall be 01 year or till the repatriation of the Executive Engineer (Civil) of CU Kerala whichever is earlier. The period may be extendable for one more year as per requirement and availability of vacancy. The deputation shall be without the provision for absorption. However, the appointed candidate shall be repatriated to his/her parent Institution at any time even before the prescribed period in case his/her performance, integrity or conduct is found to be unsatisfactory or for any other administrative reason at any stage of deputation period.
- 3) Only those candidates whose probation has been declared are eligible to apply. Candidates holding analogous post shall get priority for appointment. Selection will be made based on the number of years of service and marks awarded in the APAR and strictly as per method formulated by the Central University of Kerala.
- 4) All applicants must fulfill the eligibility conditions for the post and other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they posses at least the essential qualifications and experience laid down for the Notification as on the last date of receipt of the applications. Any time after appointment should it become noticed that the candidate does not possess the minimum eligibility or that the claim made by him/her with respect to the qualifications/experience/other credentials are false or misrepresentation of facts, then his/her appointment shall be terminated forthwith.
