Anti-Ragging Cell

In compliance with the "UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009", the University has set up an Anti-Ragging cell with the objective of prohibiting any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student; and thereby, to eliminate ragging in all its forms from the University.

The Committe takes the following measures to curb the menace of ragging:

Before and During Admission and Registration

- ☐ Briefs the prospective students on the "UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009", the admission brochure carries highlights of the Act.
- ☐ Telephone numbers of the Anti-Ragging Helpline and all the important functionaries in the University, members of the Anti-Ragging Committees and Anti-Ragging Squads, etc. are promptly displayed on the Official Websites and are included in the admission brochure
- Every student and his/her parents is required to file an affidavit avowing not to indulge in ragging.
- On admission periods, the University prominently displays posters detailing laws and punishment against ragging.
- Anti-ragging squad of the University ensures vigil at odd hours during the first few months at hostels and inside University premises.

After Admission

DErects hoardings, puts up notices and wall posters and pastes stickers to sensitise the students and staff of the gravity of the offence and to promote the values of love, peace and harmony among the student community

- Organises workshops, lectures and counselling sessions to generate awareness among the students and staff of the menace of ragging, the measures to curb it and the legal procedure for reporting ragging- related offences
- ☐Printed leaflet is given to every fresher detailing addresses and telephone numbers of the Anti-Ragging Helpline, Wardens, Head of the institution, all members of the anti-ragging squads and committees, and relevant district and police authorities.
- DEnsures that the identity of informants of ragging incidents, if any, will be fully protected.
- DEnsures that the faculty members assigned to students make surprise visits and maintain a diary of his/her interaction with the freshers.
- DEnsures that the freshers are lodged, as far as may be, in a separate hostel block. Every academic year, the Vice-Chancellor constitutes an Anti-Ragging Squad for maintaining vigil and patrolling functions. The Squad remains mobile, alert and active at all times. The Anti-Ragging Squad makes surprise raids on hostels. Discreet random surveys are conducted amongst the freshers every fortnight during the first three months. The Anti-Ragging committee submits a weekly report on the status of the compliance with Anti-Ragging measures and a monthly report on such status thereafter, to the Vice-Chancellor of the University. The Committee found it heartening that no incidence of ragging has been reported in the institution since its inception in 2009.

Grievance Redressal Cell

(For Students, Teachers and Non-Teaching Staff)

A Students' Grievance Redressal Cell following functions in the University with the objectives:

Upholding the reputation and the dignity of the University by ensuring strife free atmosphere in the University through promoting cordial Student-Student relationship and Student-teacher relationship.

Help develop a responsive and accountable attitude among all the stakeholders in order to maintain a harmonious educational atmosphere in the University.

Encouraging the Students to express their grievances freely and frankly, without any fear of being victimized.

Ensure that the suggestion/complaint boxes are installed in front of Grievance Redressal Cell and also in the respective departments in which the Students, who want to remain anonymous, can put in writing their grievances and their suggestions for improving the Academics/Administration in the

University.

Advising Students of the University to respect the right and dignity of one another and show utmost restraint and patience whenever any occasion of rift arises.

Advising All the Students to refrain from inciting Students against other Students, teachers and University administration Advising all staffs to be affectionate to the Students and not behave in a vindictive manner towards any of them for any reason.

The Students' Grievance Redressal cell of the University is empowered to redress grievances related to:

- making admission contrary to merit determined in accordance with the declared admission policy of the University~
- (ii) irregularity in the admission process adopted by the University~
- refusing admission in accordance with the declared admission policy of the University~
- (iv) non publication of prospectus, as specified~
- (v) publishing any information in the prospectus, which is false or misleading, and not based on facts~
- (vi) withhold or refuse to return any document in the form of certificates of degree, diploma or any other award or other document deposited with the University by a person for the purpose of seeking admission in the University, with a view to inducing or compelling such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue~
- (vii) demand of money in excess of that specified in the declared admission policy or approved by the competent authority to be charged by the University ~
- (viii)breach of the policy for reservation in

- admission as may be applicable~
 (ix) complaints, of alleged discrimination of
- (ix) complaints, of alleged discrimination of students, from the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Women, Minority or Disabled categories~
- (x) non-payment or delay in payment of scholarships to any student that the University is committed, under the conditions imposed by University Grants Commission, or by any other authority~
- (xi) delay in conduct of examinations or declaration of results beyond that specified in the academic calendar~
- (xii) on provision of student amenities as may have been promised or required to be provided by the University ~
- (xiii)denial of quality education as promised at the time of admission or required to be provided~
- (xiv)non transparent or unfair evaluation practices~ and
- (xv) harassment and victimisation of students, including sexual harassment~

SC/ST Standing Committee & SC/ST CELL

As per the instruction from the University Grants Commission, the SC-ST Cell was constituted in the Central University of Kerala in the year 2014 in order to process the grievances of the members belong to the SC/ST category in the University. It specifically concentrated on the welfare of the SC/ST students and staff.

For effective implementation of the policies and programmes of the reservation policy for the SC/STs in the University, a Standing Committee is constituted under the Chairmanship of the Hon'ble Vice-Chancellor.

As per UGC guidelines, the SC/ST Cell is functioning under the overall supervision of the Liaison Officer.

Cell is to monitor the guidelines issued by the

MHRD, the University Grants Commission and by the government of Kerala from time to time. The Cell ensures the effective implementation of the reservation policies in the university admissions to students in various programmes, accommodation in the hostels, appointments to the teaching and non-teaching posts, allotment of quarters and maintenance of roster register in the University.

The Cell is actively engaged in coordinating and solving the problems in admissions. It also announces details regarding government scholarships through circulars to the SC/ST students through concerned HODs.

The SC/ST students and Employees can approach the Coordinator of the Cell for Redressal of any of their grievance(s) regarding academic, administrative or social problems.

Meeting of the SC/ST Cell

The meeting of the SC/ST Cell was conducted on 19.07.2017 at 3 pm in the Conference Hall, Tejaswini Hills Campus, Kasaragod to discuss various issues related to the SC/STs in the University and submitted the same to the competent authority for further orders.

Complaint Regiter

The Cell has opened a Complaint Register on 19.08.2014 for the SC/ST students and staff of the University. So far 4 complaints were registered (one complaint during 2016-17) and out of these complaints, two have been solved and the other two are still pending. One of the pending complaint is about the non-receipt of scholarship of the students who belong to various states. The University is giving special attention and taking continuous follow-up actions for getting the scholarship from all the concerned state governments. The other one pending complaint is from a faculty and the Cell has submitted its report on the complaint to the University higher authority for further orders.

ONLINE GRIEVANCE FORM

A complaint registration page for SC/ST has been developed and linked to the website of the University. When any student submits the complaint in the form, an e-mail comes directly to the e-mail of the Registrar which will contain the contact details as well as the complaint details of the concerned complainant.

During the financial year 2017-18, only one complaint was received online on 17.7.2017 from a student regarding Hostel Admission and the necessary steps have been taken by the Cell for providing accommodation.
