

The committee discussed the revised mode of online DBT in connection with fellowships/scholarships through UGC web portal with Canara Bank as nodal agency.

2. Academic Calendar -Days of Vacation -reg


The recently concluded AG Audit (16/10/2018 to 14/11/2018) remarked the improper adoption of vacation for the Academic Community. The objection is;

As per para 14-1 of UGC Regulation 2010, if the University adopts a 5 day week pattern, then the number of weeks for vacation is 6, and if adopts 6 day week, vacation is 8 weeks, and for curtailment of vacation by 2 weeks, University teachers may be credited with 1/3rd of the period of earned leave. CUK adopted 5 day week pattern and as such the vacation admissible is 6 weeks. But as per the academic calendars, the University allows vacation of 10 weeks including Onam, Chirstmas and Summer vacation.
